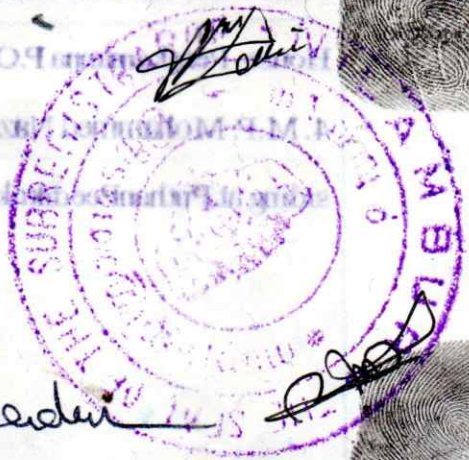

Now this deed witnesses as follows and We hereby declare as:

1. Name of the Trust:

The name of the trust shall be: Praisewill Educational and Charitable Trust.

2. Office of the Trust.

The office of the Trust shall be Athikkal Building, Main Road, Kunrummal, Edavanna 676521, Malappuram District, Kerala which may be shifted to such other places as the trustees may deem fit at their discretion.

3. Area of Operation

The area of operation will be the whole of India except the State of Jammu and Kashmir.

4. Fund and Assets:

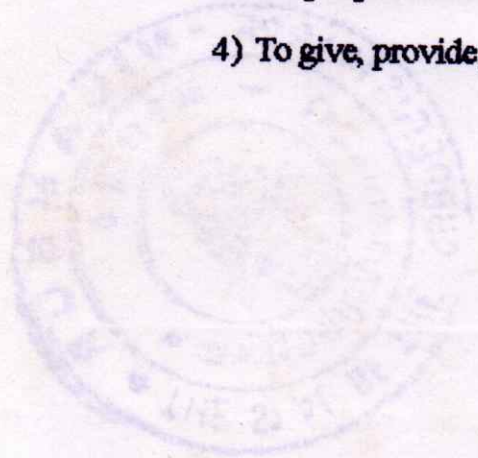
The settlors contribute a special fund for educational and charitable objects. The trust fund is Rs. 20,000 (Rupees Twenty thousand only) donated by trustees mentioned above and the said amount is transferred to trustee herein below which is subject to the rights and powers herein expressed.

5. Objects:

The objects of the Trust shall be:

- 1) To take up and manage the Praisewill Public School situated at Edavanna which has been functioning for the past four years, and continue to manage and run the school in the best of interest to the students as well as public at large.
- 2) To do all acts necessary to get recognition for the school from Central/ State Governments, Educational Boards/Departments/Universities and other authorities.
- 3) To establish, Promote, set-up run, maintain, assist, finance support and/or aid to or help in the setting up and/or maintain and/or run the above school or other schools and other institutions including schools for physically and mentally challenged children, orphans, widow homes, lunatic asylums, poor homes or other establishments for relief and/or help to the poor old and infirm people and/or destitutes.
- 4) To give, provide, set up to hold and/or render help and assistance in cash

or kind for the promotion of sports, games, extra curricular activities, cultural programmes competitions, exhibitions etc. to the students and to the public without distinction of caste, colour, or creed.

5) To publish, books periodicals, pamphlets or to advertise through various media for the betterment and promotion of the institutions/establishments under the trust.

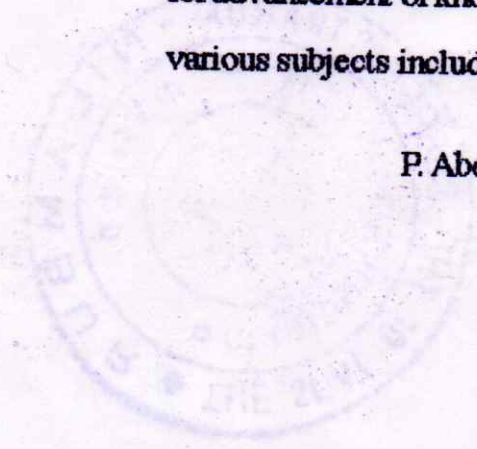
6) To install book stalls, venues, for distribution/sale of uniforms, sportswear, stationary items and other consumer articles for the betterment, convenience and promotion of the institutions/establishments.

7) To start, promote computer centres, internet facilities and such other centres and indulge in activities for creating computer literacy computer awareness among students and public.

8) To open, found, establish, promote, set up, run, maintain, assist, finance support and/or help in the setting up and/or maintaining and/or running, colleges, lecture halls and other establishments for advancement of education and knowledge in arts, science, law, literature, information technology, tourism, travel, humanities and all other useful subjects in all their manifestations.

9) To organise debates seminars, discussions, deliberations demonstrations for advancement of knowledge, information, and awareness of the public on various subjects including arts, science, literature humanities, law, politics

and all other subjects which the trust decides time to time.

- 10) To promote, advance, and encourage, establish and/or aid in helping, promoting, advancing encouraging primary, secondary and higher education including technical, medical, business managements, co-operation tourism, physical training, training of handicrafts, fine art music and other useful arts, crafts among the public.
- 11) To open found establish promote, set up, run maintain, assist, finance support and/or aid or help in the getting up and/or maintaining libraries, auditoriums and the like for the welfare and other services to the public and to provide meeting room for socially useful activities and functions.
- 12) To procure/obtain grant aid financial and/or otherwise from Central, State Governments and other authorities for the promotion, management, advancement, of educational institutions, welfare establishments and others for the betterment of the students and the public.
- 13) To establish, deliver, distribute, set up, maintain, prizes, awards, scholarships, financial aids to students, enterprenuers, outstanding persons in different fields of life.
- 14) To open found, establish, promote set up, maintain, assist, finance support and/or running hostels for students, working men, working women.
- 15) To open, found, establish promote, setup, run, maintain, assist, finance support and or running hospitals, charitable dispensaries, paramedical cen-

tres, and other similar institutions or centres for providing medical relief and/or aid to the suffering humanities physically and mentally challenged or for research centres and institutions for promotion of research and rendering help/aid for medical treatment and surgery.

16) To give, provide and render help and assistance to the unemployed youth, for promotion of self employment, vocational training, career guidance, placement assistance to the needy.

17) To give, provide and or render help and assistance for admission and coaching to various courses, competitive examinations conducted by various Boards, Universities and other institutions in India and abroad.

18) To start maintain free tuition classes for poor and/or destitute students.

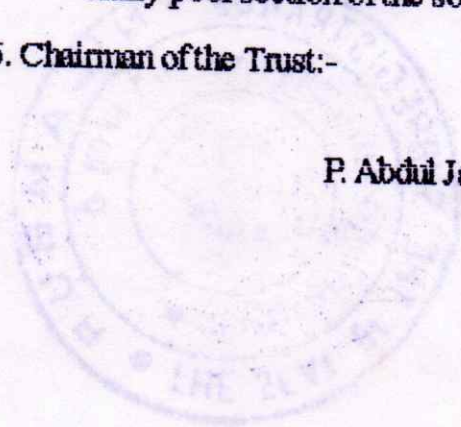
19) To do any act for the advancement of general public especially the upliftment of delits, minorities, socially and educationally backward classes, scheduled castes and scheduled tribes.

20) To receive funds by way of loans from banks or other financial institutions and/or contributions/donations from wellwishers and/or generous people from India and abroad.

21) To give, provide and/or render help assistance to and/or implement any scheme for upliftment, providing livelihood of farmers, labourers and financially poor section of the society.

6. Chairman of the Trust:-

We the trustees appoint Mr. P. Abdul Jabbar, S/o Moyin Haji, Puthiyath House, Kalikavu No. 1 among trustees as the Chairman of the Trust for a term of 5 years. On the expiry of the term the trustees shall elect one among them as the Chairman and the terms of a Chairman shall be 5 years unless otherwise resigned or deposed.

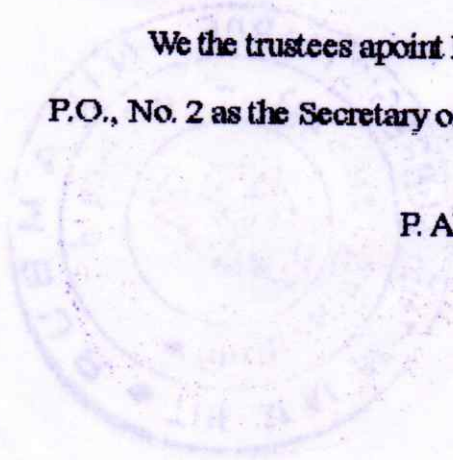
Functions of the Chairman:

- a) The Chairman will preside over the meetings, superwise the functioning of the trust and give necessary directions to the proper administration of the trust and shall represent the trust.
- b) In case of difference of opinion between the trustees the opinion of the majority shall prevail and if the trustees are equally divided in any matter, the Chairman shall have a casting vote.
- c) A resolution in writing circulated among all the trustees and signed by a majority of the trustee shall be as valid and effectual as if it had been passed at a meeting of the trustees duly called and convened.
- d) He shall execute all documents on behalf of the trust, including documents for obtaining loan from Banks or other financial aid from Banks, financial institutions, State Government or Central Government as the case may be

7. Secretary of the trust:

We the trustees appoint Mr. M. Ismail, S/o Kassim, Shaji Manzil, Vadapuram P.O., No. 2 as the Secretary of the Trust for a term of 5 years. On the expiry of this

term the trustees shall elect one among them as the Secretary and the terms of a Secretary shall be 5 years unless otherwise resigned or deposed.

The Secretary of the trust shall perform the day to day administration and management of the trust. He shall represent the trust in all legal proceedings by or against the trust.

8. Treasurer of Trust:

We the trustees appoint Mr. P. Ibrahim, S/o Mohammed kuttty, Edappatta House, Odayi, Perakamanna P.O. No. 3 as the treasurer of the trust for a term of 5 years. On the expiry of the term the Trustees shall elect one among them as Treasurer and the terms of the treasurer shall be 5 years unless otherwise resigned or deposed.

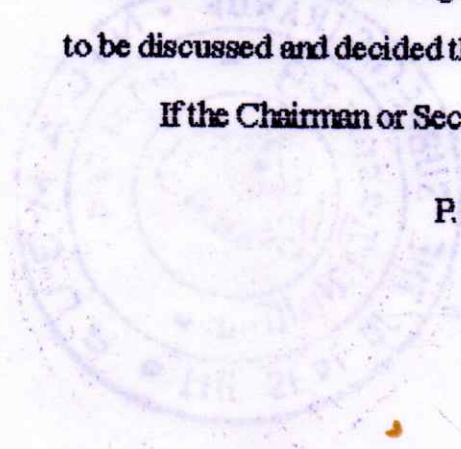
The treasurer shall be bound to keep the correct accounts of income and expenditure and of the assets of the trust.

9. Meeting of the Trust:

The trust meeting will be convened either by the Chairman, by the Secretary or by both or by any trustees authorised by the trustees on giving at least 3 days notice to the trustees but the chairman or the secretary or both or the authorised trustees shall be bound to convene the meeting within 7 days of receipt of a notice from the trustees demanding to convene the trust meeting and showing the matters to be discussed and decided therein.

If the Chairman or Secretary or both or the authorised trustees does not call

the trust meeting within such time as stated above the members who have signed the notice shall have the power to convene the trust meeting and discuss and decide the matters given in the notice.


In case the person entitled to call the trust meeting fail to carry out their duties or are in any way disabled or incapacitated to discharge their functions or continues for a period of six months the trustees can be summoned by not less than 2/3 rd of the members of the trust and in the meeting so summoned the trustees can appoint a trustee or trustees for discharging the functions of the chairman or secretary or the authorised trustee as the case may be until otherwise decided by the trustees.

10. The trust shall appoint the necessary staff employees and other officials for the functioning of the trust and establishments/institutions under the trust and shall have power to decide all matters relating to such appointments and other relevant matters in connection with the same.

11. The trust shall constitute and appoint subcommittees including experts in the concerned field to run each projects to be started by the trust.

12. The trust shall have power to acquire accept or receive all endowments gifts, grants or donations, movable and immovable made to this trust by assignments or otherwise by individuals groups, families, organisations or associations whether

incorporated or not, or by any Governments, State and Central and all such endowment, gifts, grant and donations shall be considered as part of this trust properties and their managements, income and expenditure shall be unconditionally carried on and used for as per the provisions of the deed.

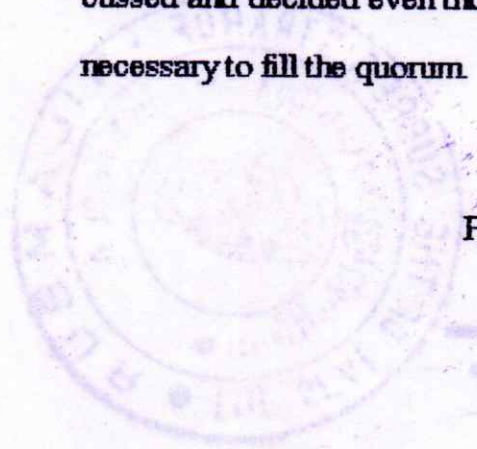
13. The trust fund shall be deposited in such bank or banks decided by the Trust in the name of the Trust and the Chairman/Secretary and Treasurer jointly shall have power to negotiate and operate in such bank accounts by issuing jointly signed cheque or bills and draw amounts.

14. The trust shall sit at least four times in a year and the members are eligible to allowance, bata or travelling allowance in such manner as and when are decided by the Trust. The Secretary will submit before the trust in every meeting the working report of the trust.

15. The quorum of the Trust shall be 1/3 and all the decision of the trust shall be in writing and by majority of the members present. The majority decision of the Trust shall not be questioned by any trustee of the trust except in a court of law but the trust will have its discretion to review its own decision.

16. In case any meeting has been adjourned for want of quorum the next meeting shall be covered within 15 days of such adjournment and the agenda may be discussed and decided even though if it is not attended to by as many members as necessary to fill the quorum.

17. The trustees by a majority of 2/3 of its members may frame necessary rules and regulations helpful to the smooth and effective management of the trust and governing its subsidiaries but such rules and regulations shall in no way be derogative to the purpose of this Trust.

18. This is a irrevocable Trust and neither the trustees nor the dependants of the trustees have any right or authority to revoke it. But the trust meeting by 2/3rd majority of its members shall have power to amend, associate or amalgamate with other Trusts constituted for similar purpose or to assign the Trust properties in favour of such other trusts.

19. The trustees can include other persons as trustees or associate trustees as per decision passed in trust meeting. Any trustee or trustees who's acts and behaviour are found detrimental to the interest of this Trust may be dismissed by a resolution approved by 2/3rd majority of the total strength of the trust.

20. The trustees shall at all times stand indemnified in respect of any act that is done by them in bonafide intention suffered or committed to be done in respect of or on relating to the trust.

21. Auditing:

The accounts of the trust shall be audited by a duly qualified accountant.

This trust is to be governed by the provisions of the Indian Trust Act, 1882
(Act 11 of 1882)


